INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

A site investigation was conducted pursuant to ECMC Rule 911 at the ERICKSON T6N-R64W-S4 L01 Facility and Tank Battery location.

PROPOSED SAMPLING PLAN

Proposed Soil Sampling

Will soil samples be collected as part of this investigation? (Number, type (grab/composite), analyses, and locations of samples):

On May 27, 2025, grab confirmation soil samples were collected from the produced water vessels excavation (PWV01-B@4', PWV01-N@2.5', PWV01-E@2.5', PWV01-W@2.5', PWV01-S@2.5'), beneath the ground oil tanks (AST01@0-6"), and dumlins (SEP01-DL@3') of any separators. In addition, the onsite dump lines located between the separator and tank battery were removed by pulling from either end. Soil samples were analyzed by a certified laboratory for the full extent of Table 915-1, including but not limited to: TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons) organic compounds in soil per ECMC Table 915-1, and EC, SAR, pH, metals, and boron. All samples collected were analyzed by a certified laboratory using approved ECMC laboratory analysis methods.

Additional alternative investigative actions described in attached Site Investigation Plan (summary):

Visual inspection at the tank battery area occurred during abandonment activities. Field personnel field screened all disturbed areas using visual and olfactory senses. Additionally, discrete soil samples were collected from the base of the excavation and excavation sidewall in areas most likely to be impacted and exhibiting the highest field screened VOC concentration. A detailed summary of tank battery decommissioning activities, including field notes, site photos, figures, and laboratory analytical results, was attached to a previous Supplemental Form 27 (ECMC document #404325674).

On 05/28/2025, three background soil samples were collected from one discrete location (BKG01) from the associated Erickson A 4-5 flowline (REM 39485) and analyzed for metals in soil per ECMC Table 915-1, pH, SAR, EC, and boron. Background soil samples were collected from depths ranging between 0 to 5 feet below ground surface (ft bgs). The maximum background concentrations with a 1.25x multiplier applied for arsenic, barium, chromium, lead, and selenium were calculated to be 6.1 mg/kg, 231 mg/kg, 0.60 mg/kg, 23.3 mg/kg, and 0.58 mg/kg, respectively. All arsenic, barium, and lead concentrations observed during decommissioning were below 1.25x the maximum background level.

Based on decommissioning analytical results, an SSI will be completed to collect additional background samples to determine if chromium, and selenium are attributed to native soil conditions at the site. The SSI will be completed in accordance with the proposed implementation schedule. The proposed soil boring locations are illustrated on the attached proposed site investigation plan.

Site has been added to the third-party drilling schedule and will proceed once third-party drilling rig equipment becomes available.

Pursuant to Rule 913.e, quarterly reporting will be conducted until closure criteria are achieved for the remediation project. The results of the supplemental site investigation will be submitted on a subsequent Form 27.
