## INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

Pursuant to ECMC Rule 911 a site investigation was conducted pertaining to the SPIKE STATE GWS CC30-02 wellhead cut and cap and flowline removal. Approximately 838' of flowline will be removed. The wellhead was cut and capped per ECMC rules. Additionally, soil samples were collected at any points of material change and/or hammer unions, directional changes, as well as at the bell holes on either side of a waterway. Flowline data referenced in ECMC Doc#403694060.

One (1) grab confirmation soil samples was collected at the wellhead and analyzed by a certified laboratory for TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons) organic compounds in soil per ECMC Table 915-1, and EC, SAR, pH, and boron. All samples collected were analyzed by a certified laboratory using approved ECMC laboratory analysis methods. Additionally, soil samples were field screened at the N-E-S-W sides of the wellhead.

Voluntary Disclosure.
