INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

Pursuant to ECMC Rule 911, a site investigation was conducted pertaining to the CSU E35-19 wellhead cut and cap on March 11, 2025. The wellhead was cut and capped per ECMC rules. Additionally, soil samples were field screened at the N-E-S-W sides of the wellhead. Approximately 1096' of flowline will be abandoned-in-place by a separate Chevron Business Partner. The ECMC will be updated in a supplemental Form 27 if a portion of the flowline is able to be removed. Soil samples will be taken along the flowline at any points of material change and/or hammer unions, directional changes, as well as at the bell holes on either side of a waterway. Flowline decommissioning is being conducted by another Chevron business Partner and will be summarized in a subsequent Supplemental Form 27.

PROPOSED SAMPLING PLAN

Proposed Soil Sampling

Will soil samples be collected as part of this investigation? (Number, type (grab/composite), analyses, and locations of samples):

A grab soil sample was collected at the base of the wellhead excavation. Soil samples will be taken along the flowline at any points of material change and/or hammer unions, directional changes, as well as at the bell holes on either side of a waterway. Soil samples were and will be analyzed by a certified laboratory for the full extent of Table 915-1, including but not limited to: TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons) organic compounds in soil per ECMC Table 915-1, and EC, SAR, pH, metals, and boron. Background soil samples will be analyzed by a certified laboratory for analysis of metals per ECMC Table 915-1 and soil suitability parameters including pH, EC, SAR, and boron. All sample analysis is performed by a certified laboratory using approved ECMC laboratory analysis methods.

Proposed Groundwater Sampling

Will groundwater samples be collected as part of this investigation? (Number, analyses, and locations of samples):

If groundwater is encountered, a grab groundwater sample will be collected and analyzed for all organic and inorganic compounds per ECMC Table 915-1; this sample analysis includes, but is not limited to BTEX, naphthalene, 1,2,4-trimethylbenzene (TMB), and 1,3,5-TMB, chloride and sulfate anions and total dissolved solids (TDS).

Visual inspection of the wellhead area occurred during abandonment activities. Field personnel field screened all disturbed areas using visual and olfactory senses to determine if laboratory confirmation sampling was required. The ECMC Wellhead Closure Checklist was utilized and filled out during the abandonment process. A photolog was previously provided.

Six site specific background soil samples collected from approximately 4 ft. and 6 ft-bgs from three soil borings (BKG01 through BKG03) and were submitted for analysis of pH, EC, SAR, and total metals (Table 915-1 List) by ECMC approved methods.

The confirmation soil samples and field screenings collected from the wellhead excavation were all classified as silty sands (SM). The six background soil samples were collected from similar depths as the confirmation soil samples with similar soil classification as the wellhead sample, silt (ML), silty gravel (GM), and silty sands (SM).

The implementation schedule has been changed due to the necessity for site investigation activities adjacent to the wellhead and the flowline.

OPERATOR COMMENT

This form is being submitted as a 4Q25 timeline update for the CSU E35-19 wellhead and flowline.

Facility closure activities and confirmation soil sampling were conducted at the wellhead on March 11, 2025, and were summarized in (Pending) Supplemental Form 27 Document #404202548. Site specific background sampling was conducted March 20, 2025 and results were summarized in (Pending) Supplemental Form 27 Document #404308230.

All analytical results for soil samples submitted for analysis are compliant with their respective Table 915-1 Protection of Groundwater Soil Screening Levels or below the highest background concentration for pH (8.70) or 1.25x the highest background concentrations for barium (270 mg/kg), except for arsenic (19.0 mg/kg), cadmium (0.391 mg/kg), and selenium (0.320 mg/kg) in soil sample WH01@6.

Flowline decommissioning is being conducted by another Chevron business partner and will be summarized in a subsequent Supplemental Form 27.

Pursuant to Rule 913.e, quarterly reporting will continue for the location until data indicates no further action is warranted.
