This form has been prepared in accordance with ECMC Rule 911.a to provide prior notice of closure of the Davis P 27-3, 6,3JI ,6JI production facility. Visual inspection and field screening of soils will be conducted following decommissioning of the associated infrastructure. Based on these observations, soil and groundwater (if present) samples will be collected and submitted for laboratory analysis of the ECMC full Table 915-1 to determine if soils are in compliance. The topographic Site Location Map showing the geographic setting of the site is provided as Figure 1.

Facility infrastructure and the proposed soil screening and sample locations are provided on Figure 2.
