## INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

Initial Site Investigation was conducted on 7/2/2025; 4 samples were collected at 3' in a addition to 2 background samples at 3'.

Background analytical indicate the Local Levels are pH (8.64), Arsenic (8.4375 mg/kg), Barium (322.35 mg/kg) and Selenium (3.975 mg/kg).

Analytical results showed exceedances for the following sample locations: SS01 pH (8.74) and SAR (14.55), Selenium (4.10 mg/kg); SS02 Chrom VI (0.45 mg/kg); SS03 pH (8.46) and SAR (30.84); SS04 pH (8.75) and SAR (27.54).

Under Groundwater Soil Screening Levels, samples exceeded Arsenic, Barium and Selenium concentration levels.

Mull respectfully requests reduced analytical suite for pH, SAR, Chrom VI and Selenium only.
