INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

Pursuant to ECMC Rule 911, a site investigation was conducted pertaining to the Albrighton D-10HN flowline abandonment on 03/13/2025. The on-location flowline was abandoned-in-place. The Form 44 Flowline Abandonment Notice Document will be included on a subsequent Form 44. This flowline lies in a common trench with at least one other line, so as to not disturb the other line(s) sharing the common trench, soil samples were taken at the wellhead and at the endpoint of the flowline. The ECMC will be updated in a supplemental Form 27 if a portion of the flowline is able to be removed.

The Albrighton D-10HN wellhead was cut and capped on 02/25/2025. Due to safety concerns and the proximity of live lines on this active facility, a site investigation could not be performed at the time. In accordance with ECMC Rule 911, a site investigation will be conducted once the adjacent wellheads are plugged and abandoned.

PROPOSED SAMPLING PLAN

Proposed Soil Sampling

Will soil samples be collected as part of this investigation? (Number, type (grab/composite), analyses, and locations of samples):

A grab soil sample will be collected at the base of the excavation or the area showing the highest degree of impact during field screening activities at the wellhead excavation. A grab confirmation soil sample will be collected at the wellhead excavation and start/end points of the flowline. Additionally, soil samples will be field screened at the N-E-S-W sides of the wellhead. Grab confirmation samples were collected at the start and endpoints of the flowline (FL01R-W@3' and FL01R-S@4'). Soil samples were analyzed by a certified laboratory for the full extent of Table 915-1, including but not limited to: TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons) organic compounds in soil per ECMC Table 915-1, and EC, SAR, pH, metals, and boron. All samples collected were analyzed by a certified laboratory using approved ECMC laboratory analysis methods.

Visual inspection of the flowline area occurred during abandonment activities. On 03/13/2025, two background samples were collected from one discrete location (BKG01) adjacent to the flowline and analyzed for metals in soil per ECMC Table 915-1, pH, SAR, EC, and boron. Background soil samples were collected from depths ranging between 3 to 4 feet below ground surface (ft. bgs). The maximum background concentration for pH was observed to be 8.22. The maximum background concentration with a 1.25x multiplier applied for arsenic and barium were calculated to be 4.23 mg/kg and 89.9 mg/kg, respectively. All arsenic concentrations observed during decommissioning were below 1.25x the maximum background level.
