A site investigation was conducted pursuant to ECMC Rule 911 at the ALLES T5N-R65W-S33 L06 Facility and Tank Battery location.

Grab confirmation soil samples were collected from the produced water vessel(s) excavation, beneath the ground oil tank(s), and at the risers for the flowline(s) and dumpline(s) of any separator(s). Soil samples were analyzed by a certified laboratory for TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons), organic compounds in soil per ECMC Table 915-1, and EC, SAR, pH, and boron. All samples collected were analyzed by a certified laboratory using approved ECMC laboratory analysis methods.

Confirmation samples AST01@6", AST02@6", SEP05@3', SEP04@4', SEP02@4.5', PWVE01@6', PWVB01@7' at the former Alles F 33-28,29D Tank Battery were submitted out of temperature preservation range. Soil will be re-sampled and analyzed for the full Table 915-1 analyte suite at the AST01@6", AST02@6", SEP05@3', SEP04@4', SEP02@4.5', PWVE01@6', PWVB01@7' sample locations at the same depth where the initial confirmation samples were collected in order to confirm initial analytical results. Noble will request a No Further Action (NFA) be granted if the reanalyzed samples comply with the Table 915-1 concentration standard. Background samples will be used to justify elevated concentrations.

Additionally, Background samples will be collected in five locations from an area not impacted by oil and gas development at similar depths and lithologies as confirmation samples collected at the location and analyzed for ECMC Table 915-1 metals and soil suitability for reclamation standards (SSR) (pH, EC, SAR, and Boron). The samples will be used to characterize native soil and potentially attribute elevated metals and inorganics concentrations to native soil conditions.
