The source was removed through mechanical excavation. Grab confirmation soil samples were collected and submitted to a certified laboratory for analysis of Table 915-1 metals and organic compounds, TPH C6-36, EC, SAR, pH, and boron to determine the lateral and vertical extent of impacts.

Source removal is complete. Five groundwater monitoring wells were installed at the location and were gauged dry. There was no groundwater encountered during excavation activities. The lithology is predominantly clay to a depth of 16' below ground surface. Table 915-1 residential screening levels will be applied to this location. EC remains in situ above ECMC standards and will be delineated laterally and vertically. A detailed reclamation plan will be submitted once laboratory data review is complete. The soil sampling analysis plan will include EC only. The estimated timeframe to achieve a no further action will be May 31, 2026.
