Initial confirmation sampling occurred on November 24, 2025. A Form 19 (Doc# 404451032) was submitted on November 25, 2025 based on elevated PID reading observations, including 318.3 ppm (and odor) at the wellhead and excavation east sidewall, and a PID reading of 180.1 ppm (and odor) at the separator excavation base. Analytical sample results will be reported on a subsequent Form 27.
