INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

This form has been prepared to support removal of a wellhead and on-location flowline. The flowline was removed. In accordance with COGCC Rule 911 and Rule 915, initial representative soil samples will be collected beneath the wellhead. Initial laboratory soil analysis will include only BTEX, 1,2,4 and 1,3,5 Trimethylbenzene, naphthalene, TPH, pH, EC, SAR and boron. Soil samples collected beneath the off-location flowline will be field screened, and a lab analysis submitted if impacts are identified. Groundwater, if present, will also be collected and analyzed.

Seventeen grab soil samples were collected for analysis of Table 915-1 TPH C6-36, organics, EC, SAR, pH, boron, and metals.

Source removal paused to evaluate past Summit Scientific laboratory data. A total of 11,581 cu/yds of impacted material was removed through excavation and disposed at a certified landfill. Soil samples will be collected for the ECMC approved, amended Table 915-1 soil analysis plan that includes TPH C6-36, organics, arsenic, barium, cadmium, lead, nickel, selenium, pH, EC, SAR, and boron.

REMEDIATION SUMMARY

Describe how remediation of existing impacts to soil and groundwater is to be accomplished (i.e. summarize remedial action plan). Additional source removal may occur to remove impacts above ECMC standards. No groundwater was present during excavation activities. a confining layer of claystone is present at 17' below ground surface, a pathway to groundwater does not appear to be present at the remediation location. The estimated timeframe to achieve a no further action will be August 31, 2026.
