A site investigation was conducted pursuant to ECMC Rule 911 at the TREBOR T5N-R64W-S12 L03/Trebor B12-03, 04 Tank battery location on 10/09/2024.

Grab confirmation soil samples were collected from the produced water vessel(s) excavation, beneath the ground oil tank(s), at the risers for the flowline (s) and dumphline(s) of any separator(s). In addition, the on-site dump lines located between the separator and tank battery were removed by pulling from either end. Soil samples were analyzed by a certified laboratory for the full extent of Table 915-1, including but not limited to: TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons) organic compounds in soil per ECMC Table 915-1, and EC, SAR, pH, metals, and boron. All samples collected were analyzed by a certified laboratory using approved ECMC laboratory analysis methods.

Four background soil samples were collected from one discrete location (BKG01) near the tank battery and analyzed for metals in soil per ECMC Table 915-1, pH, EC, SAR and boron. Background soil samples were collected from depths ranging between 0.5 to 4 feet below ground surface (ft bgs). The maximum background concentration for pH was observed to be 8.47. The maximum background concentrations with a 1.25x multiplier applied for arsenic and barium were calculated to be 2.46 mg/kg and 221 mg/kg, respectively. All arsenic and barium concentrations observed during decommissioning were below background levels.
