Interim areas are primarily composed of intermediate wheatgrass with secondary amounts of Russian wildrye and tertiary amounts of fourwing saltbush. Desirable, perennial and uniform vegetation is present. Cheatgrass and weedy annual mustards are scattered in tertiary amounts throughout the interim areas; however, weed management is not required at this time. Weed management may be required in 2026.
