Describe what is known about the spill/release event (what happened -- including how it was stopped, contained, and recovered):

On 9/18/2025, Cache 8-13, 24, 34; Cornish 8-53 tank battery decommissioning activities were completed. During the completion of the activities, no potential presence of impacted material(s) was observed/smelled. Consistent with Rule 912, samples were collected and analyzed to determine whether any constituents were present at levels in excess of Table 915-1 standards. Final laboratory analytical results received on 11/25/2025 indicate that soil sample PWV01-W, PWV01-N, discovered at the former produced water vessel, exceeded ECMC Table 915 standards for 1-methylnaphthalene at 0.0091 mg/kg & 0.0134 mg/kg. Groundwater was encountered during re sampling activities and sample taken. This site is within the Mule Deer Sever Winter Range High Priority Habitat, also this location is within 300 feet of waters of the state. The supplemental Form 27 has been submitted for remediation number 40661, document number: 404402875.

PDC conducts routine AVO inspections of all oil and gas facilities in order to identify and mitigate potential releases. Further, this facility is no longer active and is in the process of being decommissioned.
