In accordance with Rule 218.f.1., Transfer of Operatorship – Subsequent, SG Interests I, Ltd. (SGI), Buying Operator, would like to inform the Colorado Energy and Carbon Management Commission (ECMC) that Gunnison Energy, LLC (GELLC), has transferred select assets to Buying Operator SGI. The transaction is to be considered confidential and any other associated information confidential pursuant to § 24-72-204(3)(a)(IV), C.R.S. SGI and GELLC submit this letter of attestation and associated documents to notify the ECMC of the transfer of assets.

Per Rule 218.f.(1), included as Attachment A is the Transferable Items list associated with this transaction.
