Dear Mr. Freese,

Crestone Peak Resources Operating, LLC (CPR), a wholly owned subsidiary of Civitas Resources Inc. would like to request permission to use the surface locations of the above referenced wells (the "Wells") in order locate and plug said Wells.

CPR intends to locate, re-enter and re-plug the Wells, in accordance with the DJ Basin Horizontal Offset Policy, as set forth by the Colorado Energy & Carbon Management Commission ("ECMC").

The Wells will be plugged in accordance with the lease rights granted by the State of Colorado. A 100' x 100' area surrounding the surveyed locations of the Wells will be designated as the disturbance area. Once the Wells are located, a 300' x 300' area will be designated as the pad location for plugging operations. If the Wells cannot be located in the 100' x 100' disturbance area, then CPR will cease operations and contact the State Land Board to discuss further efforts to locate the Wells.


CPR shall remove and properly dispose of all trash, equipment, materials, and deadmen associated with each re-entry site upon completion of plugging operations.

Following completion of re-plugging operations, CPR shall consult with the State Board of Land Commissioners regarding reclamation measures prior to initiating any reclamation activities, to ensure compliance with lease terms and Land Board requirements.

Upon review of oil and gas lease no. OG 1960.12, CPR will adhere to biologic lease stipulations associated with the mentioned lease. CPR intends to accommodate any timing or location issues that may affect its plugging operations.

Enclosed please find a satellite photo depicting the potential locations of the Wells with associated access routes. A surveyed plat will be provided once it has been completed by the survey company. Per our on-site consultation on 12/12/2025, should you find the locations satisfactory, please sign and return the attached acknowledgement.
