In general, the areas of interest tend to be where the lines transition from subsurface to above-ground at each end of a line and soil adjacent to the wellhead. Grab samples will be collected from soil vertically below these areas and submitted for laboratory analysis of all analytes listed in COGCC Table 915-1. If a flowline is connected to a production separator where there are other lines and/or production equipment to be abandoned in the future, no samples will be collected. These areas of the location will be assessed in the future during subsequent abandonments.
