Operator Comment: KMOG prioritizes assessment and remediation at locations based on restrictions and stipulations including potential receptors, wildlife, land use, landowner access, receiving director's approval prior to commencing operations addressed by the Form 27, etc.

KMOG prioritizes remediation at sites located within Bald Eagle Nest buffers from August 1st through November 30th so although crops may be harvested, they are not the highest priority during this time. Additionally, agricultural limitations such as crops being left in place, various seeding and/or harvesting windows, and unforeseen weather events and field conditions impact KMOG's ability to complete remediation at crop hold locations throughout the year and from year to year.

KMOG updated the language in Form 27 (Document # 404484878) to reflect that work is being prioritized at this location following crop harvest and was resubmitted 12/23/25.
