There is a cattle guard that remains at the midpoint of the access road that must be removed. The location fence can now be removed and post holes will need to be filled in with soil. Any associated disturbance will need to be reclaimed.

Corrective Action: Comply with 1004 Rule. Remove cattleguard and fence.
