In response to the COA issued on approved Form 19 Document No. 404396786 regarding the third party utilities, the impacted soil was discovered near a Black Diamond Gathering line, owned by Noble/Chevron and a Sinclair Pipeline Company line owned by HF Sinclair Corporation. The location of these lines are illustrated in Figure 2. Additional investigation is ongoing.
