QB Energy met with ECMC Staff Alex Fisher, John Heil, Nick Cholas, and Collin Metz on December 9th and requested guidance regarding submittal of Supplemental Form 27 documents with no work completed during the quarter. Guidance from the ECMC regarding a path forward is pending receipt. QB Energy will plan to continue investigation and/or remediation during the 1st quarter of 2026 and will report to the ECMC on supplemental documentation.
