SUNDRY NOTICES AND REPORTS ON WELLS

INSTRUCTIONS

Notice must be given to the Director, and approval obtained in advance of the time when the owner or operator expects to recomplate or abandon a well or to change plans. Within thirty (30) days after recompletion, change of plans, or remedial work, a detailed report of the work done and the results obtained shall be submitted on this form in duplicate for wells on Patented and Federal lands, and in triplicate for wells on State lands. In work that affects only rods, pumps or tubing or other routine work such as, but not limited to, cleaning out to previous total depth, no report is necessary.

(DETAILS OF WORK)

- Plans are:
- (1) To spot a regular cement plug from 5350' to 5400' with 10 sacks of cement. Well is now perforated 5408' to 5411.5'. Total Depth inside 5 1/2" 15.5# casing is 5430'.
 - (2) Shoot off 5 1/2" casing at 4400', or above top of Niobrara.
 - (3) Recover all possible 5 1/2" casing.
 - (4) Spot 20 sack cement plug in bottom of 10 3/4" surface casing and a 10 sack cement plug in top of surface casing.
 - (5) Weld steel plate over top of surface casing, 2' below ground level.
