**INITIAL ACTION SUMMARY**

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

Pursuant to ECMC Rule 911 a site investigation was conducted pertaining to the SHABLE 14-22 wellhead cut and cap. The wellhead was cut and capped per ECMC rules. Additionally, soil samples were field screened at the N-E-S-W sides of the wellhead. The flowline was previously abandoned on 11/21/2018, and the ECMC was notified on Form 44 Document Number 403216829.

One grab soil sample was collected at the wellhead excavation, and soil samples were field screened at the N-E-S-W sides of the wellhead. Soil samples were analyzed by a certified laboratory for the full extent of Table 915-1, EC, SAR, pH, metals, and boron. All samples collected were analyzed by a certified laboratory using approved ECMC laboratory analysis methods.

Operator is proposing to collect a confirmation grab sample at the initial sample location of WH-FS-01 at 7ft and 9ft bgs, along with 4 delineation samples offset of 10 ft from WH-FS location in N, S, W, and E direction at depths of 7 and 9 ft bgs to assess the vertical and horizontal extent. These samples will be collected and analyzed for the full extent of Table 915-1 compounds, EC, SAR, pH and boron.
