INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

CPW and USFS granted Murfin special access to continue wellhead excavation and confirmation soil sampling only during USFS archeological review and CPW Lesser Prairie Chicken hold. On 7/23/25, additional excavation and confirmation soil sampling occurred. Confirmation grab soil samples were collected from the east sidewall, south sidewall, and the floor of the new excavation. Impacts were observed in the south sidewall and floor samples. Only the east sidewall soil sample EX01-SS-05@4' was submitted to Origins Laboratory in Denver, Colorado for full ECMC Table 915-1 analysis. Lab results confirm Table 915-1 compliance in EX01-SS-05@4' at the east sidewall. Additional excavation and confirmation sampling is needed at the south sidewall and floor of the excavation. See attached figures, tables, photo log, and laboratory analytical reports for all work completed since previous SF27 document number 404204687 was submitted on 5/14/25, which has not yet been reviewed by ECMC.
