INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

CPW and USFS granted Murfin special access to complete wellhead excavation and confirmation soil sampling only during USFS archeological review and CPW Lesser Prairie Chicken hold. On 4/16/25, the additional material was removed from the wellhead cut/cap excavation where initial assessment soil sample WH-FS-01@4' failed. Confirmation grab soil samples were collected from the 4 sidewalls and the floor of the new excavation and submitted to Origins Laboratory in Denver, Colorado for full ECMC Table 915-1 analysis. Lab results confirm that impacted soil remains in of the sidewalls and additional excavation and confirmation sampling is needed. See attached figures, tables, photo log, and laboratory analytical report for all work completed since previous SF27 document number 404085388 was submitted on 2/6/25, which has not yet been reviewed by ECMC.

Additional excavation and confirmation grab soil sampling is needed at the wellhead sidewalls. Floor sample EX01-FS-01@5' is fully compliant with Table 915-1 Protection of Groundwater Soil Screening Level limits, confirming impacts did not reach groundwater. Murfin would like to request ECMC approval to use Table 915-1 Residential Soil Screening Level limits going forward.
