On 12/15/2025, Burough C 23-30D flowline decommissioning activities were completed. During the completion of the activities, no potential presence of impacted material(s) was observed/smelled. Consistent with Rule 912, samples were collected and analyzed to determine whether any constituents were present at levels in excess of Table 915-1 standards. Final laboratory analytical results received on 12/29/2025 indicate that soil sample FL01 & FL01 (Burough C14-13D), discovered along the flowline & located in the same excavation and considered one release. exceeded ECMC Table 915 standards for TPH at 641 mg/kg & 558 mg/kg. Groundwater was not encountered during decommissioning activities. All data collected will be submitted with the next quarterly Supplemental Form 27 for REM 21022.
