INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

Pursuant to COGCC Rule 911 a site investigation will be conducted pertaining to the EASTON 12-01 wellhead cut and cap and flowline removal. Approximately 691' of flowline was removed. The wellhead was cut and capped per COGCC rules. Additionally, soil samples were collected at any points of material change and/or hammer unions, directional changes, as well as at the bell holes on either side of a waterway, AS APPLICABLE to abandonment type. The Flowline Pre-Abandonment Notice Document number was included under Related Forms.

A grab soil sample was collected at the base of the excavation or the area showing the highest degree of impact during field screening activities at the wellhead excavation. Additionally, soil samples were collected at any points of material change and/or hammer unions, directional changes, as well as at the bell holes on either side of a waterway, AS APPLICABLE to abandonment type. A grab confirmation soil sample was collected at the wellhead excavation. Soil samples were analyzed by a certified laboratory for ECMC Table 915-1 compounds. All samples collected were analyzed by a certified laboratory using approved COGCC laboratory analysis methods.

Background soil samples to be obtained sufficiently away from the impacted areas to reflect conditions not impacted by oil and gas activity, and from similar depths and soil horizons or lithologic materials for comparison to confirmation soil samples will be collected as appropriate for flowline background and analyzed for ECMC Table 915-1 SSR parameters and metals.

Field personnel screened all disturbed areas using visual and olfactory senses to determine if laboratory confirmation sampling is required. A detailed summary of decommissioning activities at the wellhead and flowline risers, including an ECMC Flowline Closure and Wellhead Closure Checklist, site photos, figures, and laboratory analytical results, were attached to Supplemental Form 27 # 403516354 and # 403903883 respectively.

OPERATOR COMMENT

This 2Q25 SF27 for Easton 12-1 is an update on data validation and confirmation sample planning for the site.

Operator has elected to conduct confirmation soil sampling at the well head at 6- feet below ground surface (ft bgs) and along the flowline at 3- and 4- ft bgs and analyzing for full ECMC Table 915-1 analytes including metals. Background soil samples to be obtained sufficiently away from the impacted areas to reflect conditions not impacted by oil and gas activity, and from similar depths and soil horizons or lithologic materials for comparison to confirmation soil samples will be collected as appropriate for flowline background and analyzed for ECMC Table 915-1 SSR parameters and metals.

In response to ECMC Form 27 Comment dated 02/06/25 (Document Number 403903883), Operator is submitting a replacement Form 27. Based on currently available data, this project is not affected by data integrity irregularities and is not associated with Operator's data integrity review process and its Rule 525.e. Voluntary Disclosure. As part of its data integrity review process, Operator requested the lab protect the laboratory analytical report from subsequent unauthorized modification by anyone outside the lab, which resulted in the lab reissuing the original report with additional protections (2212236 - Noble - Easton.pdf). The Reissued Report was received directly from the lab on 4/10/25, which includes the application of a Digital ID/Verified Certification (lock) to support reissuance. The metadata associated with this Reissued Report also includes the lab representative's name, the date and time the laboratory reissued the report, and an explanation for the report reissuance. The Reissued Report is attached to this submission.

In the event additional responsive information is received or discovered that would suggest this project should be incorporated into the ongoing data integrity review process associated with Operator's Rule 525.e. Voluntary Disclosure, Operator will update and/or amend the statements in this submission and provide any new or revised data or other information responsive to ECMC's general comments responding to Operator's Form 27 submission found in Document Number 403903883.

Pursuant to Rule 913.e, quarterly reporting will continue for the location until data indicates no further action is warranted.
