INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

The once operative skim pit subject to Remediation Project# 7798 was decommissioned around June 2013 by PADCO LLC. At the time of decommissioning, PADCO introduced appropriate fill material into the excavated pit and compacted the soil to match the footprint of the former skim pit, located on lands immediately adjacent to an existing evaporation pit at the site.

The former skim pit was located along the east wall of the currently active evaporation pit; additional site investigation of this area at this time would affect the integrity of the active pit berm/wall. The operator is proposing soil borings at the locations illustrated on the attached figure to determine if any impacts remain in place. The east wall will be further investigated during site decommissioning in accordance with ECOM Rule 911.c.

PROPOSED SAMPLING PLAN

Proposed Soil Sampling

Will soil samples be collected as part of this investigation? (Number, type (grab/composite), analyses, and locations of samples):

Soil samples will be collected from the soil boring during installation from the interval with the highest PID reading and from the terminal depth of the soil boring. Samples will be submitted to a NELAP-accredited lab for the full Table 915-1 list of analytes. Drilling activities, including soil sampling, analytical results, and boring logs will be provided in a Form 27-S report.

Proposed Groundwater Sampling

Will groundwater samples be collected as part of this investigation? (Number, analyses, and locations of samples):

If groundwater is encountered during facility decommissioning activities, a minimum of one grab sample will be collected as soon as practical. Groundwater samples will be submitted to a NELAP accredited laboratory for analysis of benzene, toluene, ethylbenzene, total xylenes (BTEX), naphthalene, 1,2,4-TMB, and 1,3,5-TMB using standard methods appropriate for detecting the target analytes in CECMC Table 915-1.

In 2013 the skim pit was emptied by vac truck; fluids take to licensed disposal site. Contaminated earthen liner has been excavated to apparent clean soil and stored on a plastic liner with containment to prevent run-off.

Any additional hydrocarbon-impacted material will be transported off-site to a licensed disposal facility in accordance with Rules 905 and 906

REMEDIATION SUMMARY

The once operative skim pit subject to Remediation Project# 7798 was decommissioned in or around June 2013 by PADCO LLC. Records of disposal of E&P waste along with sample locations and testing of samples (which conformed to then Rule 910 concentration levels) were not timely recorded with ECMC or are nonexistent. At the time of decommissioning, PADCO introduced appropriate fill material into the excavated pit and compacted the soils with the footprint of former skim pit located on lands immediately adjacent to an existing evaporation pit found on the location.
