The well location and access road appear to meet final reclamation regulations and standards; crop vegetation is reflective of adjacent reference areas. Unable to find evidence of oil and gas activities and/or disturbances.

The associated tank battery falls in a corner crop area which has already been harvested, tank battery will need to be re-inspected at a future date to confirm compliance with revegetation rules and standards.

Operator remains responsible for monitoring and managing this site until the location passes final reclamation, including storm water and weed management.
