A site investigation will be conducted pursuant to COGCC rule 911 at the Aristocrat Angus 3-3N-65WSESE (484411) oil and gas location pertaining to the removal of (1) oil tank and (1) separator. All other wells and equipment will remain active. See site map exhibit for details.

Grab confirmation soil samples will be collected from beneath the above ground oil tank and separator. Soil samples will be analyzed by a certified laboratory for TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons), organic compounds in soil per COGCC Table 915-1, and EC, SAR, pH, and boron. All samples collected will be analyzed by a certified laboratory using approved COGCC laboratory analysis methods.
