## INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

Pursuant to ECMC Rule 911 a site investigation was conducted pertaining to the TODD 20-02 wellhead cut and cap on 5/17/2024 and flowline removal on 8/22/2024. Approximately 1058' of flowline was removed. The wellhead was cut and capped per ECMC rules. Additionally, soil samples were field screened at the N-E-S-W sides of the wellhead. Soil samples were also taken along the flowline any points of material change and/or hammer unions, directional changes, as well as at the bell holes on either side of a waterway. The August 22, 2024, flowline decommissioning sample results were summarized via supplemental Form 27 document number 404232344, which remains "In Process" at the time of this submittal.

The confirmation soil samples collected during wellhead cut and cap activities were determined to be outside of the required temperature preservation range when delivered to the laboratory. Re-sampling was conducted on May 22, 2025.

## PROPOSED SAMPLING PLAN

### Proposed Soil Sampling

- Will soil samples be collected as part of this investigation? ( Number, type (grab/composite), analyses, and locations of samples ):

A grab soil sample was collected at the base of the excavation or the area showing the highest degree of impact during field screening activities at the wellhead excavation. Additionally, soil samples were field screened at the N-E-S-W sides of the wellhead. Soil samples were taken along the flowline at any points of material change and/or hammer unions, directional changes, as well as at the bell holes on either side of a waterway. Soil samples were analyzed by a certified laboratory for the full extent of Table 915-1, including but not limited to: TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons) organic compounds in soil per ECMC Table 915-1, and EC, SAR, pH, metals, and boron. All samples collected were and will be analyzed by a certified laboratory using approved ECMC laboratory analysis methods.

Visual inspection of the wellhead and flowline areas occurred during abandonment activities. Field personnel field screened all disturbed areas using visual and olfactory senses to determine if laboratory confirmation sampling was required. The ECMC Flowline Closure and Wellhead Closure Checklists were utilized and filled out during the abandonment process. A detailed summary of wellhead re-sampling activities, including field notes, site photos, figures, and laboratory analytical results, is attached to this Form 27.

Six background soil samples were collected from three locations near the wellhead on June 30, 2025 and analyzed for Table 915-1 metals in soil and Soil Suitability for Reclamation parameters per ECMC Table 915-1. The background soil samples were collected from a depth of 4 and 6 feet below ground surface (ft bgs). The lithology between the site and background locations was observed to be poorly graded sands. The maximum background concentrations with a 1.25x multiplier applied for arsenic was calculated to be 5.61 mg/kg at 6 ft bgs. All arsenic concentrations observed during wellhead decommissioning were below background levels. As such, arsenic should be considered resolved at the wellhead. Additional background samples will be collected along the flowline to determine site specific background concentrations of pH, EC, and arsenic, and near the wellhead to determine site specific concentrations of pH.
