INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

Pursuant to ECMC Rule 911 a site investigation was conducted pertaining to the UPRR 39 PAN AM G 1 wellhead cut and cap and flowline removal. Approximately 1250' of flowline was removed. Approximately 60' of flowline was abandoned-in-place due to field constraints. The wellhead was cut and capped per ECMC rules.

A grab soil sample was collected at the base of the excavation or the area showing the highest degree of impact during field screening activities at the wellhead excavation. A grab confirmation soil sample was collected at the wellhead excavation. Two (2) grab soil samples were collected from the cut points adjacent to the portion of flowline abandoned in place. One (1) additional grab soil sample was collected at the flowline terminus. Soil samples were analyzed by a certified laboratory for TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons) organic compounds in soil per ECMC Table 915-1, EC, SAR, pH, and boron. One (1) soil sample was collected for waste characterization of ECMC Table 915-1 metals. All samples collected were analyzed by a certified laboratory using approved ECMC laboratory analysis methods.

Residual petroleum hydrocarbon impacts identified at the site were removed through excavation. Soil samples were collected for analysis of TPH C6-36, Table 915-1 organics in soil, and selenium per supplemental Form 27 #403182236. Soil samples were collected to confirm the vertical and lateral extents of the impacts following source removal. Results of the excavation/confirmation sampling indicate that all current organic concentrations at the flowline terminus are in compliance with ECMC Table 915-1 regulatory limits.

A background sample was collected from similar lithologic soil for pH, SAR, arsenic, and selenium analysis. The pH value was outside of the Table 915-1 regulatory limit of 6 -8.3 for pH, with a value of 8.33. The arsenic value was also above the Table 915-1 regulatory limit, with a value of 2.31 mg/kg, and a 125% Maximum Background Concentration of 2.89 mg/kg.

Soil samples were collected for analysis of TPH C6-36, Table 915-1 organics in soil, and selenium per supplemental Form 27 #403182236. Soil samples were collected to confirm the vertical and lateral extents of the impacts following source removal. Results of the excavation/confirmation sampling indicate that all current organic concentrations at the flowline terminus are in compliance with ECOMC Table 915-1 regulatory limits.

Results of the excavation/confirmation sampling indicate that all current organic concentrations at the flowline terminus are in compliance with ECMC Table 915-1 regulatory limits. Verification soil samples will be collected to confirm the pH values near FL-SS-10 and FL-SS-11. Elevated pH levels will be delineated and further remediation will be proposed on a supplemental Form 27 as needed. NFA will be considered when soil concentrations are in compliance with ECMC Table 915-1 standards.

The Operator has conducted a detailed data screening of historical site investigation analytical data for this REM collected by the prior consultant (Eagle Environmental). This review included review of laboratory analytical data reports and investigation reporting materials compared to corresponding encrypted analytical reports issued by the laboratory. Completion of this data screening was necessary in order to determine if analytical results generated by the prior consultant could be utilized to inform the project's remediation strategy and development of next steps. Given the meticulous nature of the data screening and considering the impact the screening results could have on the project strategy/life cycle, all site activities and associated compliance reporting was temporarily put on hold for this facility. Therefore, this Timeline Update serves to notify ECMC of the following:

- Historical site investigation activities/results have been verified by the data screening and can be utilized for technical decision making purposes.
- The Operator has reviewed historical data to inform the next steps (i.e., addressing prior COAs, scheduling additional site investigation to collect delineation and background samples, conducting remedial actions, or compiling forms for NFA consideration).

Additional details/next steps will be provided in the subsequent Supplemental Form 27 submittal which is anticipated for submittal to ECMC within 90-days, post regulatory approval of this Timeline Update.
