INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

Pursuant to ECMC Rule 911 a site investigation was conducted pertaining to the WARDLAW 20-28 wellhead cut and cap. The wellhead was cut and capped per ECMC rules. The flowline was previously abandoned prior to the 2018 Registration rules. The flowline is now planned for removal, and the ECMC will be updated in a supplemental Form 27 when a portion of the flowline is able to be removed. Soil samples will be taken along the flowline at any points of material change and/or hammer unions, directional changes, as well as at the bell holes on either side of a waterway.

PROPOSED SAMPLING PLAN

Proposed Soil Sampling

Will soil samples be collected as part of this investigation? (Number, type (grab/composite), analyses, and locations of samples):

Soil samples will be taken along the flowline at any points of material change and/or hammer unions, directional changes, as well as at the bell holes on either side of a waterway. Soil samples were analyzed by a certified laboratory for the full extent of Table 915-1, including but not limited to: TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons) organic compounds in soil per ECMC Table 915-1, and EC, SAR, pH, metals, and boron. All sample analysis was performed by a certified laboratory using approved ECMC laboratory analysis methods.

Proposed Groundwater Sampling

Will groundwater samples be collected as part of this investigation? (Number, analyses, and locations of samples):

If groundwater is encountered, a grab groundwater sample will be collected and analyzed for all organic and inorganic compounds per ECMC Table 915-1; this sample analysis includes, but is not limited to BTEX, naphthalene, 1,2,4-trimethylbenzene (TMB), and 1,3,5-TMB, chloride and sulfate anions and total dissolved solids (TDS).

Additional alternative investigative actions described in attached Site Investigation Plan (summary):

Visual inspection of the wellhead area occurred during abandonment activities. Field personnel field screened all disturbed areas using visual and olfactory senses to determine if laboratory confirmation sampling was required. The ECMC Wellhead Closure Checklist was utilized and filled out during the abandonment process. A photolog was submitted in a previous Supplemental Form 27.

Were background samples collected as part of this site investigation?

Six site specific background soil samples collected from approximately 4 ft and 6 ft-bgs from three soil borings (BKG01 through BKG03) and were submitted for analysis of pH, EC, SAR, and total metals (Table 915-1 List) by ECMC approved methods.

The confirmation soil samples and field screenings collected from the wellhead excavation were all classified as sandy clay (SC). The six background soil samples were collected from the same depths as the confirmation soil samples with the same soil classification as the wellhead samples.

All analytical results for soil samples submitted for analysis are compliant with their respective Table 915-1 Protection of Groundwater Soil Screening Levels or below the highest background concentration for EC (7.36 mmhos/cm) and SAR (10.4) or 1.25x the highest background concentrations for arsenic (7.25 mg/kg) and selenium (0.463 mg/kg), except for barium (134 mg/kg) in soil sample WH01@6.

Noble proposes to conduct additional background soil sampling from boring locations at similar depths and soil horizons as confirmation soil samples, in areas away from oil and gas infrastructure to further investigate residual inorganic concentrations in soil at the site. Flowline decommissioning is being conducted by another Chevron business partner and will be summarized in a subsequent Supplemental Form 27.

This form is being submitted as a 1Q26 timeline update for the Wardlaw 20-28 wellhead.

Facility closure activities and confirmation soil sampling were conducted at the wellhead on April 28, 2025, and were summarized in Supplemental Form 27 Document #404287680.

Noble proposes to conduct additional background soil sampling from boring locations at similar depths and soil horizons as confirmation soil samples, in areas away from oil and gas infrastructure to further investigate residual inorganic concentrations in soil at the wellhead. Background soil samples will be analyzed for analysis of metals per ECMC Table 915-1 and soil suitability parameters including pH, EC, SAR, and boron.

Flowline decommissioning is being conducted by another Chevron business partner and will be summarized in a subsequent Supplemental Form 27.

Pursuant to Rule 913.e, quarterly reporting will continue for the location until data indicates no further action is warranted.
