The background soil samples were collected from a depth of 4.5 feet below ground surface (ft bgs). The lithology between the site and background locations was observed to be poorly graded sands. The maximum background concentration for pH is 8.33. The maximum background concentrations with a 1.25x multiplier applied for arsenic was calculated to be 5.88 mg/kg at 4.5 ft bgs. All arsenic concentrations observed during decommissioning were below 1.25x maximum background levels. As such, arsenic should be considered resolved. Additional background samples were collected to determine site specific background concentrations of SAR, on October 24, 2025. The implementation schedule has been changed due to the decommissioning of the WELLS RANCH USX AA 13-07 wellhead and necessity for supplemental site investigation activities adjacent to the wellhead. A supplemental site investigation (SSI) was completed on October 24, 2025 to collect additional background samples. Final analytical results are pending and will be summarized in a subsequent Form 27.

OPERATOR COMMENT

This Form 27 is being submitted to include a 4Q 2025 update for the WELLS RANCH USX AA 13-07 wellhead (REM #40521) and the decommissioning results at the former wellhead location. A supplemental site investigation (SSI) was completed on October 24, 2025 to collect additional background samples to determine if elevated levels of SAR were attributed to native soil conditions at the site. Final analytical results are pending and will be summarized in a subsequent Form 27.

Three background soil samples were collected near the wellhead on August 18, 2025 and analyzed for Table 915-1 metals in soil and Soil Suitability for Reclamation parameters per ECMC Table 915-1. The background soil samples were collected from a depth of 4.5 feet below ground surface (ft bgs). The lithology between the site and background locations was observed to be poorly graded sands. The maximum background concentration for pH is 8.33. The maximum background concentrations with a 1.25x multiplier applied for arsenic was calculated to be 5.88 mg/kg at 4.5 ft bgs. The flowline was previously abandoned on 6/21/2017, and the ECMC was notified on Form 44 Document number 402033212.

Pursuant to Rule 913.e, quarterly reporting will be conducted until closure criteria are achieved for the remediation project. The results of the supplemental site investigation will be submitted on a subsequent Form 27.
