Flowline impacts were discovered during flowline decommissioning. Source unknown. During flowline decommissioning fresh water was used to flush the line and was all recovered. The crew also used 50lbs of pressure using a compressor and did not see a drop prior to decommissioning; however, the crew does not keep pressure test documentation for decommissioning. The line was dry cut at each bell hole and no there was no introduced chemical additives that would cause naphthalene detections.
