It was observed in this inspection that the Location has not been reclaimed per 1004 Rules; trash/debris and equipment remains; It does not appear that the Location has been properly decompacted nor revegetated; bare ground and undesirable plant species dominate the plant community. The reference area vegetation is a salt scrub community.
