INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

On Sunday, April 6, at approximately 6 pm, Noble incurred a well control incident near Galeton in Weld County at the Bishop Well. Noble notified the Galeton Fire Department and immediately activated emergency response procedures, mobilized an extensive cross-functional team of subject matter experts, and worked closely with the Galeton community and Fire Department. The Bishop Well was secured on 4/10/2025. Unified Command (UC) stood up on 4/7/2025 to undertake initial actions and emergency response measures. On 4/14/2025, UC stood down and Noble's Incident Command (IC) took over, continuing emergency response measures in coordination with UC agencies. The investigation into the incident is ongoing and response activities continue to abate and remediate impacts associated with E&P waste.

This Form 27 addresses impacts within Parcel T087-1 with an approximate area of 2.28 acres, more specifically depicted on the Site Overview Map ("Incorporated Lands"). Separate Form 27s will be submitted to address abatement, investigation, and remediation activities associated with other land parcels potentially impacted by the Bishop Well incident.

PROPOSED SAMPLING PLAN

Proposed Soil Sampling

Will soil samples be collected as part of this investigation? (Number, type (grab/composite), analyses, and locations of samples):

Soil sampling is underway consistent with the Environmental Sampling Analysis Plan (ESAP) v2.0, and Residential Soil Sampling Locations Plan (RSSLP) v1.3. To date, 21 soil samples have been collected. Final validated laboratory data for the preliminary sample collected on 5/15/25 were previously submitted on a Form 27 Supplemental (Document #404274154). Laboratory analytical results for the comprehensive soil samples collected on 6/14/25 were previously submitted on a Form 27 Supplemental (Document #404366022). Confirmation samples were collected on 11/14/25 but laboratory analytical results are pending. Of the 21 collected samples, 20 parent samples were analyzed, and 1 was used for quality assurance activities. ESAP analyte exceedances were reported for 15 samples.

Noble is implementing a multi-phase approach to determine the extent of potential impacts to soil, surface water, and/or groundwater, which will be used to generate a fit-for-purpose remedial action plan. Both visual and olfactory observations and initial PID readings are being relied upon to qualitatively screen for potential soil, surface water, and/or groundwater impacts. Samples are being collected for laboratory analysis to determine whether any analyzed constituent exceeds an applicable threshold or limit. Such identified exceedances will be incorporated into the evaluation of proposed remediation approaches (e.g., in situ, ex situ, monitoring), which will be submitted for review and approval.

Remedial excavation activities occurred on 11/14/25 as described in the operator comment.

Remedial actions will be initiated consistent with ECMC approval of Form 27.

OPERATOR COMMENT

Soil samples exceeding the Residential Soil Screening Levels (RSSLs) were previously reported on Form 27 Supplemental (Document #404274154). On November 14, 2025, the RSSL exceedances were addressed by excavating an approximate 10 by 10-foot area to a depth of approximately 12 inches. The attached figure shows the RSSL exceedance location and estimated excavation area. Excavation activities were guided by visual and olfactory observations and photoionization detector readings. Confirmation soil samples were collected from the base and sidewalls of the excavation and analyzed in accordance with the ESAP. An agronomic sample was also collected from the base of the excavation and analyzed in accordance with the Agriculture and Residential Reclamation Sampling Analysis Plan (ARRSAP). Excavated soils were managed and disposed of in accordance with ECMC 913.b.(3) to the Ault, Colorado Waste Management landfill. Backfill provided from 4X Hatton location was placed following confirmation sampling in accordance with the ARRSAP. Upon receipt of the confirmation sample analytical results, the data will be validated and then submitted to ECMC. Soil sampling results from the 4X Hatton (B402) location are attached.

As noted above, this Form 27 is limited to the site investigation and associated remediation activities within Incorporated Lands.

Separate Form 27s will be submitted to address other parcels with potential impacts from the Bishop Well incident.

To support remedial activities, operator is submitting separate Form 27s to address potential impacts associated with agricultural and residential lands and parcels have been subdivided to represent agricultural or residential lands. As such, the previous lat/long coordinates provided were the center of the parcel as defined by the county property boundaries but may not represent the center of the subdivided agricultural and residential lands.

Estimated volumes, dates, and investigation/remediation approaches are subject to revision based on the receipt of additional data being generated as part of ongoing response efforts, including site investigation tasks.

Background samples have been collected, and final analytical results are pending lab validation.

Samples collected to date with validated Supplemental Site Investigation data for soil are attached to this Form 27. To date, 21 soil samples were collected. Final laboratory analytical results for the preliminary samples were previously submitted on a Form 27 Initial (Doc #404274154) and comprehensive samples were previously submitted on a Form 27 Supplemental (Document #404366022). Confirmation samples were collected on 11/14/25, but laboratory analytical results are pending. To date, 21 soil samples were collected. Of the 21 collected samples, 20 samples were analyzed and 1 was used for quality assurance activities. ESAP analyte exceedances were reported for 15 samples.

The waste volumes provided in the Soil Remediation Summary and Waste Disposal sections of this F27 have been automatically rounded to whole numbers. Total E&P waste is comprised of approximately 3.76 cubic yards of impacted soil.
