Comment This inspection was conducted during the dormant season. Interim areas are used by cattle and grazing pressure is evident. Interim areas appear to be predominantly bare or composed of weedy annual mustards, prickly Russian thistle and cheatgrass. Inspector could not fully evaluate 1003 compliance at the time of inspection; a follow-up inspection will be conducted to determine compliance with 1003 reclamation requirements.

Weed control is required at the location. Weed management should be conducted during the time of year when treatment efforts are most effective; a follow-up inspection will be conducted during the 2026 growing season to evaluate weed control efforts at the location.
