On 12/31/2025, Northwest Reclamation Specialist Maxwell conducted a Final Reclamation Inspection at True Oil LLC's BTA Federal 12-33 Location in Moffat County, Colorado.

The well was PA'd 2/27/2020 (Doc #402352602); flowlines were abandoned 06/05/2020 (Doc #402414788) and is located on federal surface.

The Location is in the following HPH: 1202.d. density for Greater sage-grouse priority habitat management, Elk Severe Winter Range, Mule Deer Winter Concentration Area and Pronghorn winter concentration.

Comment:

At the time of the previous inspection, final reclamation was in process. It was observed in this inspection that the Location and access road is progressing towards 1004 Reclamation standards. The Location and access road appears to have been re-contoured and seeded, with some vegetation progressing. Some areas appear to have lower vegetation establishment which may be due to compaction. Additional reclamation activities may need to occur if vegetation does not progress. A spring follow-up inspection may be required to observe vegetation growth.

Corrective Action:

If available, submit an approved Final Abandonment Notice (FAN) attached to an FIRR indicating surface reclamation has been passed per Bureau of Land Management standards.
