INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

Pursuant to ECMC Rule 911 a site investigation was conducted pertaining to the Cache 17-52 wellhead cut and cap and flowline removal. Approximately 204' of flowline was removed on July 2, 2025. Soil samples were taken along the flowline any points of material change and/or hammer unions, directional changes, as well as at the bell holes on either side of a waterway. The wellhead was cut and capped per ECMC rules on July 29, 2025. Additionally, soil samples were field screened at the N-E-S-W sides of the wellhead. Following receipt of the flowline removal information, the wellhead flowline riser was collected on July 2, 2025 and denoted as FL01-02@2.5'. The separator flowline riser sample (SEP01-FL@2.5') was collected on July 2, 2025, and was reported under CACHE-66N63W 17NENW (REM #40649).

PROPOSED SAMPLING PLAN

Proposed Soil Sampling

Will soil samples be collected as part of this investigation? (Number, type (grab/composite), analyses, and locations of samples):

A grab soil sample was collected at the base of the excavation or the area showing the highest degree of impact during field screening activities at the wellhead excavation. Additionally, soil samples were field screened at the N-E-S-W sides of the wellhead. Soil samples were taken along the flowline at any points of material change and/or hammer unions, directional changes, as well as at the bell holes on either side of a waterway. Soil samples were analyzed by a certified laboratory for the full extent of Table 915-1, including but not limited to: TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons) organic compounds in soil per ECMC Table 915-1, and EC, SAR, pH, metals, and boron. All samples collected were analyzed by a certified laboratory using approved ECMC laboratory analysis methods.

Additional alternative investigative actions described in attached Site Investigation Plan (summary):

Visual inspection of the wellhead and flowline areas occurred during abandonment activities. Field personnel field screened all disturbed areas using visual and olfactory senses to determine if laboratory confirmation sampling was required. The ECMC Flowline Closure and Wellhead Closure Checklists were utilized and filled out during the abandonment process. A detailed summary of wellhead decommissioning activities, including field notes, site photos, figures, and laboratory analytical results, was previously attached to Form 27 document number 404357791. A detailed summary of flowline removal activities, including field notes, site photos, figures, and laboratory analytical results, is attached to this Form 27.

Six background soil samples were collected from three locations near the wellhead and flowline on August 14, 2025 and analyzed for Table 915-1 metals in soil and Soil Suitability for Reclamation parameters per ECMC Table 915-1. The background soil samples were collected from depths of 3 and 4 feet below ground surface (ft bgs). The lithology between the site and background locations was observed to be well- and poorly-graded sands.

The maximum background concentration with a 1.25x multiplier applied for arsenic was calculated to be 3.55 mg/kg at 3 ft bgs. All arsenic concentrations observed during decommissioning were below 1.25x Max background levels. As such, arsenic should be considered resolved. Additional background samples will be collected to determine site specific background concentrations of pH and selenium.

The implementation schedule has been changed due to the decommissioning of the CACHE 17-52 wellhead and flowline and necessity for supplemental site investigation activities adjacent to the wellhead and flowline.

OPERATOR COMMENT

This Form 27 is being submitted to include a 1Q 2026 update for the CACHE 17-52 wellhead and flowline (REM #40465) and the flowline removal results at the former CACHE 17-52 wellhead and flowline location. A supplemental site investigation (SSI) will be completed to collect additional background samples to determine if elevated levels of pH and selenium are attributed to native soil conditions at the site. The SSI will be completed in accordance with the proposed implementation schedule, and the results of the SSI will be submitted on a subsequent Form 27.

The Site Map attached to the Form 27 Initial (ECMC Document Number 404197176) included one soil sample on the endpoints of the flowline at the site. The separator flowline riser sample (SEP01-FL@2.5') was collected on July 2, 2025 and reported under CACHE-66N63W 17NENW (REM #40649). Additionally, the wellhead flowline riser was collected on July 2, 2025 and denoted as FL01-02@2.5'.

Six background soil samples were collected from three locations near the wellhead and flowline on August 14, 2025 and analyzed for Table 915-1 metals in soil and Soil Suitability for Reclamation parameters per ECMC Table 915-1. The background soil samples were collected from depths of 3 and 4 feet below ground surface (ft bgs).
