On 10/30/2025, the potential presence of impacted material(s) was identified via hydrocarbon odor and hydrocarbon staining during the decommissioning at the Great Western Sugar 1, flowline, samples: FLR01 located at the wellhead flowline riser. The volume of potentially impacted material(s) is not currently known. Final laboratory analytical data indicated a historical release was discovered during the flowline decommissioning. one soil sample, FLOR01 & FLR01-COMP, exceeded ECMC Table915 standards for 1,2,4-trimethylbenzene at 0.067 mg/kg, naphthalene at 0.014 mg/kg, TPH at 871 mg/kg, fluorene at 0.792 mg/kg, 1-methylnaphthalene at 0.009 mg/kg & 0.299 mg/kg, and 2-methylnaphthalene at 0.079 mg/kg. Groundwater was not encountered during decommissioning activities. The supplemental Form 27 has been submitted for remediation number 42731 detailing the remedial site plan, document number: 404515678.
