Three background soil samples were collected from three locations near the wellhead on August 18, 2025 and three background soil samples were collected on October 24, 2025 and analyzed for Table 915-1 metals in soil and Soil Suitability for Reclamation parameters per ECMC Table 915-1. The background soil samples were collected from a depth of 5 and 4.5 feet below ground surface (ft bgs). The lithology between the site and background locations was observed to be poorly-graded sands. Additional background samples will be collected to determine site specific background concentrations of arsenic and lead.
