Additionally, groundwater monitoring well (DWR permit number 310849, receipt 3687464) was installed approximately 0.90 miles to the northwest recorded a static water level of 55 feet bgs. This well log is attached to this form. Both well logs for these wells are attached to this Form 27. Based on the depth to recorded static water levels, Bonanza Creek Energy Operating Company requests that Residential Soil Screening Level Concentrations apply to this remediation.
