The location and flowline disturbance have not revegetated and consist mostly of undesirable weeds which were not controlled. The undesirable weeds should have been controlled (mowed) throughout the growing season. The tall dead weed cover will need to be mowed and/or removed before the flowline and location disturbance can be reseeded. Reseeding will need to be performed before the upcoming growing season. The reclamation must be maintained for weed control and to establish desirable vegetation.
