Operator Comment: NueVida (NVR) acknowledges that there are several small tears in the liner along the northern berm in the TUA Pad that need repaired. There are no D&C operations ongoing on either the TUA or Well Pads during winter/early spring due to CPW wildlife strips from 12/01 through 04/30 each year. The TUA Pad is inactive & secured with all tanks and equipment off of the location. Cement barriers are set at all entrances to block any

potential traffic onto the Pad. NVR's practice (has been, and) is to inspect and repair the liner during May (2026) prior to any operations that will be conducted on the TUA Pad. Liner repairs in the colder winter months are not preferred as the "welding technique" used has potential to have poor sealing vs warmer operational months. The reason for the liner in the TUA Pad is for the produced water (requirement by CECMC of minimum of 3% produced water in D&C operations) that is stored in a MLVT during stimulation operations. The liner is for containment of produced water in case of a potential MLVT leak and/or liner failure. When the MLVT's are removed at the end of operations each year, the potential for a produce water spill is eliminated and the TUA Pad is then secured.

Refer to attachment: NVR\_SWMP-Management Summary 2025. NueVida (NVR) has complied with all necessary SWMP repairs except for the small area in the SW corner of the TUA Pad. The SW area of the TUA Pad noted in the FIR was extremely soft and had water accumulation due to the 6-day storm event (50-year event) that occurred in October 2025. NVR determined that attempting repairs in the SW corner of the TUA Pad would be difficult due to the very wet conditions and could result in damage of the liner as well as create additional erosional problems on the specific slope. In addition, this SW area of the TUA Pad has very good containment of any erosional discharge (soil/water). NVR determined that this SW area of the TUA Pad would not effectively dry out prior to CPW wildlife restrictions (12/01 - 05/01) in order to attempt any repairs. NVR will plan repairs accordingly in May 2026, once wildlife restrictions are lifted and the SW area has dried out sufficiently for proper repairs.
