The well was PA'd 2/27/2020 (Doc #402352602); flowlines were abandoned 06/05/2020 (Doc #402414788) and is located on federal surface.

The Location is in the following HPH: 1202.d. density for Greater sage-grouse priority habitat management, Elk Severe Winter Range, Mule Deer Winter Concentration Area and Pronghorn winter concentration.
