INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

On November 18, 2025, a release of approximately 2.5 bbls of oil within containment was identified at the Cannon 15N,16N,16C-3HZ production facility. As such, a Form 19 Initial Spill/Release Report (Document No. 404440780) was submitted on November 21, 2025, and the ECMC issued Spill/Release Point ID 492364. This form has been prepared in accordance with ECMC Rule 911.a to provide prior notice of partial closure of the Cannon 15N,16N,16C-3HZ production facility. Visual inspection and field screening of soils will be conducted following decommissioning and replacement of one aboveground storage tank (AST), one produced water vessel (PWV), and one vapor recovery tower (VRT). Based on these observations, soil and groundwater (if present) samples will be collected and submitted for laboratory analysis of the ECMC full Table 915-1 to determine if soils are in compliance. The topographic Site Location Map showing the geographic setting of the site is provided as Figure 1.

PROPOSED SAMPLING PLAN

Proposed Soil Sampling

Will soil samples be collected as part of this investigation? (Number, type (grab/composite), analyses, and locations of samples):

Following partial facility decommissioning activities, discrete soil samples will be collected from the surfaces and excavation areas. Samples will be analyzed for all analytes listed in ECMC Table 915-1. Soil samples will be submitted to an accredited laboratory for analysis using standard methods appropriate for detecting the target analytes in ECMC Table 915-1. Facility infrastructure and the proposed soil screening and sample locations are provided on Figure 2.

Proposed Groundwater Sampling

Will groundwater samples be collected as part of this investigation? (Number, analyses, and locations of samples):

If groundwater is encountered during partial facility decommissioning activities, a minimum of one grab sample will be collected as soon as practical. Groundwater samples will be submitted to an accredited laboratory for all analytes listed in ECMC Table 915-1 Organic Compounds in Groundwater and Groundwater Inorganic Parameters using standard methods appropriate for detecting the target analytes in ECMC Table 915-1.

Laboratory data indicate that total petroleum hydrocarbons, benzene, toluene, ethylbenzene, total xylenes, 1,2,4- and 1,3,5-trimethylbenzene, polycyclic aromatic hydrocarbons, arsenic, barium, and hexavalent chromium exceeding the ECOM Table 915-1 allowable levels are present at the WP01@3' location. Groundwater was not encountered during release assessment activities. Excavation activities are ongoing and details will be provided in a subsequent Form 27 supplemental report.
