Perform reclamation in accordance to ECMC 1004 rules reclamation requirements including, but not limited to, compaction alleviation, recontouring/ re-grading, removing cattle guard, and establish vegetation with total perennial, non-invasive uniform plant cover of at least eighty (80) percent of pre-disturbance or reference area levels on the location and access road. Use a seed mixture requested by the surface owner, or a mixture prescribed by the local county NRCS. Ensure erosion controls are implemented to stabilize the seeded soil, and continue to monitor and manage this site until Final Reclamation has passed.
