A site investigation will be conducted pursuant to COGCC rule 911 at the Latham 34-2 (432800) oil and gas location pertaining to the removal of (4) GL Line Heaters. All other equipment will remain active. See site map exhibit for details.

Grab confirmation soil samples will be collected from beneath the GL Line Heaters. Soil samples will be analyzed by a certified laboratory for TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons), organic compounds in soil per COGCC Table 915-1, and EC, SAR, pH, metals, and boron. All samples collected will be analyzed by a certified laboratory using approved COGCC laboratory analysis methods.
