There are no occupied buildings or livestock within a mile of the site. The location is within the CPW HPH lesser prairie chicken connectivity area and estimated occupied range.

This form serves as notification for the decommissioning of the Sayles 33-29 #4 wellhead. The ground and subsurface shall be inspected for hydrocarbon impacts during equipment removal. At a minimum, soil sampling shall be conducted in the proposed locations discussed below and shown on the attached proposed soil sample location map.

One (1) discrete grab soil sample will be collected as shown in the proposed sample location diagram, adjacent to the capped well casing. Four (4) field screening surface soil samples be collected in each cardinal direction surrounding the wellhead and one (1) background sample will be collected from an adjacent, upgradient location. The grab sample will be utilized for full Table 915-1 listed constituents. The background sample will be analyzed for EC, SAR, pH, boron, and metals.
