Hi Steve,

Well Name: Sater 19E-323

API: 05-123-42064

We had 5 psi bradenhead pressure on the well this morning. We performed a CBL (please see attached).

Based on the CBL and the bradenhead pressure, we would like to perforate at +/-370' and attempt to establish circulation. If we are unable to establish circulation at that depth, then we would like to perforate shallower and attempt to establish circulation shallower in the well (next perf and circulation attempt would be +/-100' and then +/-50' perforating at the shallower depths if we are unsuccessful at circulating at the deeper depths). If we are successful with circulating, we will perform a minimum of an overnight shut in to monitor the well and we will let you know the results.

Please let me know if you approve of this plan forward.

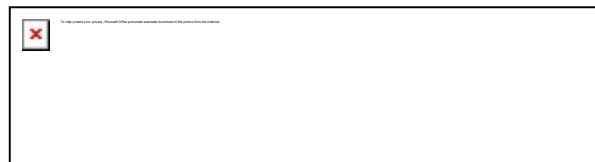
